Updated Vaccines for Influenza and COVID-19 Now Available

New flu and COVID-19 vaccines are now available at pharmacies, health authority clinics and some primary care providers' offices across the province. Seniors 65+ may be eligible to receive an enhanced flu vaccine. Notifications with a direct booking link began going out to everyone registered in the Get Vaccinated System in October and will continue to early November.

Old Age Security Pension Increase Clarified

The Office of the Seniors Advocate has become aware of confusion regarding a large increase in federal government Old Age Security (OAS) pension payments. A federal political party recently moved to increase OAS payments for seniors over the age of 75 but was unsuccessful.
